
On this date, we, the Board of Trustees of the New Braunfels ISD School District, hereby levy or set the tax rate on \$100 valuation for the District for the tax year 2021-2022 at a total tax rate of \$ 1.1978, to be assessed and collected by the duly specified assessor and collector as follows:

\$ 0.8720 for the purpose of maintenance and operations, and


\$ 0.3258 for the purpose of payment of principal and interest on debts.

Such taxes are to be assessed and collected by the tax officials designated by the District.

**AN ORDER TO SET THE TAX LEVY OF THE NEW BRAUNFELS
INDEPENDENT SCHOOL DISTRICT FOR 2021 (FISCAL YEAR 2021-2022)**

BE IT ORDERED by the Board of Trustees of the New Braunfels Independent School District, that the following taxes are hereby levied for the year 2021 on all property, real, personal, and mixed, located within the boundaries of the New Braunfels Independent School District and subject to taxation by it for the year 2021 under the laws of this State, and of the United States, a total ad valorem tax of \$1.1978 on each One Hundred Dollars (\$100.00) property valuation in this District for the purposes and in the specific amounts which follow:

I.

An ad valorem tax of \$.8720 on each One Hundred Dollars (\$100.00) property valuation for the local maintenance fund of the New Braunfels Independent School District.

II.


An ad valorem tax of \$.3258 on each One Hundred (\$100.00) property valuation for the interest and sinking fund of the New Braunfels Independent School District.

III.


The ad valorem tax levy of \$1.1978 on each One Hundred Dollars (\$100.00) property valuation shall become due and payable on or about October 1, 2021 and become and be considered delinquent if not paid by January 31, 2022.

The foregoing Order was offered by Keith D. Smith, seconded by Nancy York, and, after discussion, adopted by the Board of Trustees of the New Braunfels Independent School District by a vote of 7 to 0 at a meeting duly called and held on August 9, 2021, at which a quorum was present.


